Child Nutrition Program Overview

Ed Aylesworth, Director of Nutrition and Support Services, provided an update on the district's Child Nutrition program during the COVID-19 pandemic.

March 2020

- Worked with the Office of Superintendent of Public Instruction (OSPI)
- Hot meals daily
 - o From regular meal program to Summer Food Service Program (SFSP)
 - Sign-up system
 - Containers
 - Transportation
 - Training
- Up to 25 sites were set up
- Families pick up at the community sites
- Worked with the food bank to provide Meals til Monday on the weekends.

September 2020- Return to on-site learning

- Summer Food Service Program format
- Daily meals to students on site as buildings re-opened
- Provided weekly meal packs-families pick up at school site
- All schools
- Continued Meals til Monday program

- o Seamless Summer Option
 - Regular meal pattern
 - School in session only
- Summer Food Service
 - Reimbursement
- Systems of service
 - o On-site only
 - Varies
 - Grab and go
 - Serve on trays/plates
 - Classrooms and cafeterias
- Meals
 - Challenges
 - Increased participation
 - Decreased availability of product
 - Frequent changes to reflect available products
 - Supply Chain
 - Increased staffing needs just to prepare, bag, serve meals
 - Additional hours
 - Lack of applicants/subs
 - o Participation- The number of breakfasts and lunches has dramatically increased this year.

Future Status

Is there a dietician that reviews the food? We have to follow the guidelines. We also have a service that does a nutritional analysis for us.

Changes we're now experiencing:

- Cannot give students plasticwear, they have to ask for it or self select it
- Stryofoam will be going away
- Can't use bundled napkin and silverware

How long are the waits for meals? It's not as long as Ed thought it was. Can get through in about 5-7 minutes. At elementary schools, it's all hands on deck.

Regarding the difficulty of finding more staff, have we contacted culinary programs? We've been fortunate to get quality, qualified people.

Continue discussion of becoming more green and decarbonizing schools

Based on last meeting's discussion, Chrys would like to form a sub group to see how the district can become more green. Begin conversation and start talking about it. There are tough choices to make. Only Chrys and Sarah are part of the tasks force at this point. Brian Lewis attended tonight's meet to listen to the discussion.

Sarah shared a powerpoint from Salt Lake City School District. It was their sustainability report.

District/School Informational Update

Dr. Sweting shared the following:

- The district had a two-hour late start today due to the weather. The maintenance staff has done an amazing job of keeping the roads and sidewalks clear at our schools.
