2018 Bonds to construct and renovate school facilities and improve security

In November, the Arlington Public Schools Board of Directors adopted a resolution calling for an election on Feb. 13, 2018. Arlington voters will be asked to authorize the district to issue \$107.5 million in bonds to build a replacement for Post Middle School and improve safety and security at all school buildings in the district. Approval would not result in a tax rate increase from the rate that district voters paid in 2017.

NO LOCAL TAX RATE

Compared to the local school tax rate in 2017.



Local school tax rates in 2017 were \$4.93 per \$1,000 of assessed value. If bond is approved, taxes would start in 2019 with a local schools tax rate of \$3.74 per \$1,000, dropping to \$3.12 per \$1,000 in 2021 through 2039.

Proposed Improvements

- Install secure entry systems, improved door locks and security cameras at all schools.

- Replace Post Middle School.

- Add eight classrooms, STEAM workshop and bus shelter at Arlington High School.

- Add fire suppression system to Eagle Creek Elementary.

- Provide classroom amplification systems at all elementary schools to promote student achievement.

- Improve heating, ventilation and air conditioning at all schools for better indoor air quality and energy efficiency.

- Replace flooring at Eagle Creek and Kent Prairie Elementary schools.

Why issue bonds now?

- Bonds issued in 2000 to build Arlington High School paid off in 2020.
- Bond interest rates are near historic lows saving community money on improvements.
- The Facilities Advisory Committee, working since 2013, has identified projects to improve academic achievement, safety, security and efficiency at all school buildings.
- Renovation of Post Middle School would cost at least 75% of building new and that's just to meet code requirements, not improve instructional spaces.





Why Rebuild Post Middle School?

- Modernization costs 75%-80% of new construction just to meet code requirements (Seismic, indoor air quality, energy, acoustic, ADA accessibility, electrical and plumbing systems)
- Modernization does not address educational deficiencies (Security, room size, type of rooms, daylighting)
- Portions of the building would have to be closed during modernization, would need to locate or acquire temporary space for students



Senior Exemption

Persons at least 61 years of age and who earn less than \$40,000 annually may qualify for an exemption from local school taxes. For additional information about eligibility or to apply for an exemption, contact the Snohomish County Assesser's Office at 425-388-3433.

Over the summer, drilling took place near Post Middle School to ensure the soil could safely accommodate the building of a new middle school on the site.

What are state matching funds?

State matching funds are paid to districts from the state of Washington to assist with the construction of school buildings. Arlington would receive state matching funds due to replacement of Post Middle School. The district intends to use the funds to purchase a site for a fifth elementary school.

Sample of Secure Entryway

A single point of entry into a school helps school staff monitor who is entering and leaving a building. In addition, a secure entryway can further improve safety and security. At the start and end of the school day, the doors would be unlocked to allow students to enter and leave school. However, once school started, the inner doors would be locked.

There are many configurations for a

vestibule/double entry system. An intercom/video call box is located outside the school, and the main office screens a visitor via this system while the visitor is still outside. Visitors granted access through the primary entrance are required to pass through the main office. The office would allow visitors to enter the first entrance but the secondary entrance would remain locked.

One reason for holding the event at Post Middle School was so that parents and community members could see first-hand the need for a new middle school. The school board approved placing a bond on the Feb. 13 ballot to fund the building of a new Post Middle School and adding a wing to Arlington High School. In addition, the bond would include safety and security upgrades at all schools in the district to further protect students and staff. This would all be done with no increase to local property taxes since it would replace a 2000 bond that's expiring. This publication provides detailed information about the bond. I encourage you all to vote in the Feb. 13 election.
