This position is a two-year commitment, to be served during your Junior and Senior years. Student Advisors are expected to attend all regular Board meetings (generally two per month), special meetings/workshops (generally four-six per year), and occasional special events, such as conferences or graduations.

In accordance with Board Policy 1250, the functions of the Student Advisors are to:

1. Represent the students of the district through communication with the Board of Directors.
2. Convey student opinion to the Board regarding items under consideration.
3. Report to the Associated Student Body regarding Board deliberations and actions.

The Student Advisors will be full participants in all Board discussions and will be bound by all rules and regulations pertaining to the regular Board members. The Student Advisors will not have the right to make motions, vote, or hold Board office, and may attend Executive Sessions only by invitation.
